



# Mixed Breed Dog Club of California Mini Mutt Match

## Sunday, September 26, 2010

### Open exclusively to MBDC of CA Members and their Guests

- WHERE:** **Jose Higuera Adobe Park, Milpitas, CA** – North end of the park, near the Adobe and restrooms. There is plenty of space for crating but very little shade, so please bring your own or arrange to share. Rings are outdoors on grass.
- FROM the NORTH** – Take 680 S to Milpitas. Take the Scott Creek Rd exit. Turn **left** onto Scott Creek Rd (under freeway). At the first stop sign, turn **right** onto Green Valley Rd (becomes N Park Victoria Dr) and go about half a mile. Turn **left** onto *Wessex Pl.*
- FROM the SOUTH** - Take 680 N to Milpitas. Take the *Jacklin Rd* exit. Turn **right** onto *Jacklin Rd* (away from freeway). At the first stoplight, turn **left** onto *N Park Victoria Dr* and go about a mile. Turn **right** onto *Wessex Pl.*
- OBEDIENCE:** **Novice, Open, Utility.** Judge: Darleen Filena. Only first runs will be eligible for a leg.
- MBDCA RALLY:** **Novice, Advanced, Excellent.** Judge: Emily Barton. Only first runs will be eligible for a leg.
- CONFORMATION:** **Class I, II, III Dogs; Class I, II, III Bitches; Best Mixed Breed.** Judge: Bill Griffiths. Dogs must be registered with MBDCA to show in Conformation.
- PRE-ENTRY:** **\$12 per class.** Pre-entries close 5:00 PM, Tuesday, September 21, 2010. A judging schedule will be e-mailed after close of entries to all entrants (schedules will not be snail-mailed!).
- DAY-OF-MATCH:** \$15 per class day-of match. Day-of-match entries will be accepted before 9:00 AM and will run after all pre-entries.
- TIME:** Rally and Obedience begin at 9:00 AM. Conformation to follow conclusion of all classes, around 12:00 PM.

**MATCH RULES:** There will be one ring for Obedience and one ring for Rally and Conformation. Pre-entered dogs trying for legs will be judged in each class first, followed by all other pre-entries, then all day-of-match entries. No electric / shock collars on grounds. Food may be used, but not dropped on ground. Please be considerate of those dogs trying for legs.

**STEWARDS AND RING SUPPORT:** Please volunteer to steward or provide ring support - note below where you will be able to help out. This will be a small event with only two rings to manage, so if everyone could volunteer to work even a little bit, we will all be able to participate and things will run quickly and smoothly. Dedicated stewards will receive one free entry to a future MBDC of CA event!
